### Dog Registration:

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$10.00. You may register your dog online at <http://nasda.dog/registration/>.

### Rules:

For complete rules, visit nasda.dog. League Rules: Dogs must stay in the same level of competition throughout the league. No move ups or move downs will be accepted. Dogs need not participate every week to compete. League scoring will be calculated on Base Points only. Dogs will be ranked on by the greatest number of points with the least amount of time in each level as follows:

1. Fluffy	75 pts	0:29.10
2. Boofer	75 pts	0:32.82
3. Spot	74 pts	0:15.10

Dogs may enter more than one level they are eligible to compete in, for example, a dog with a Level II title may compete in both Urban I and Urban II during the league. There is a separate entry fee for each level. For example, a dog entered in Urban Locating I and Urban Locating II on Week 1 will pay \$25 USD per class for a total of \$50. Dogs will be scored within each level. Dogs will earn Best of Breed and High in Trial points toward new titles.

### Awards:

Awards will be handed out at the conclusion of the trial. Ribbons are awarded for qualifying score, Best of Breed and High in Class. New title ribbons will be awarded.

- Weekly: Prize for First, Second and Third Overall Place in each class
- Overall: First Place Each Division – Ribbon, Gift Bag, \$25 USD entry credit for ANY NASDA Event
- Overall: Second – Ribbon, Gift Bag, \$15 entry credit for ANY NASDA Event
- Overall: Second – Ribbon, Gift Bag, \$5 entry credit for ANY NASDA Event

### Venue:

Exhibitors will be crating in their vehicles. **North American Sport Dog Association** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog.

### Notice to Exhibitors:

- Refunds will be mailed 7 days after the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to **North American Sport Dog Association**.
- **North American Sport Dog Association** reserves the right to refuse any entry without cause or explanation.
- Trial begins at 7:15 PM.
