Awards

Pre-Entries Only: \$25 per entry (9 or more entries of a single dog \$20 per entry)

Judging will be limited to 6 hours

ENTRIES REQUIRING A SIGNATURE FOR DELIVERY WILL NOT BE ACCEPTED

Refund Policy

No refund for a dog that is absent or withdraws after closing. No refund for a dog that is disqualified, excused or barred from competition by the Trial Committee. Refunds will be given for injured or deceased dogs with written notification to the test Chair with an accompanying note from a veterinarian. Participants exhibiting COVID symptoms should contact the Trial Chair. Any refunds will be credited 7 days after the event.

Participant Information

- Smoking is NOT ALLOWED unless you are in your vehicle.
- No concessions are provided at the event. **No water or snacks will be provided.**
- This event is outdoors on private property.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms
- It is expressly understood the exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it their turn to run.
- Please pick up after your dog and put bags in red buckets.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be payable to **Hat Trick Caos**.
- Hat Trick Caos reserves the right to refuse any entry without cause or explanation.

RELEASE AND WAIVER OF LIABILITY

In consideration of the acceptance of this entry and in return for my being allowed to participate in this event with the opportunity to win prizes, ribbons, and/or trophies, I hereby **RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE**, the North American Sport Dog Association, Hat Trick Caos, LLC ("HTC"), its members, directors, governors, officers, agents, event secretary and chair, other event officials and the owner(s) or lessor of the premises and any provider of services that is necessary to hold this event and any employees or volunteers of the aforementioned parties and any BHC approved judge or presenter, presenting or judging at this event ("RELEASEES"), from any and all liability of any nature including, but not limited to, any claim, and/or cause of action arising out of or related to any loss or damage, theft, disappearance, or injury, including death that may be sustained by me or my dog arising out of participation in this event or that occurs as a result of my traveling to and from this event. I agree to **INDEMNIFY AND HOLD HARMLESS** the RELEASEES from any and all liability of any nature, including, but not limited to, loss, liability, damage or costs, including court costs and attorneys' fees, that RELEASEES may incur due to my participation in this event and my traveling to and from this event, arising out of injury, death, theft, disappearance, loss or damage or other that is caused or alleged to be caused by my dog, other dogs, my negligence, the negligence of the RELEASEES, or by the negligence of any other persons.

It is my express intent that this **RELEASE AND WAIVER OF LIABILITY** shall bind the members of my family if I am alive and my heirs, assigns and personal representative, if I am deceased and shall be deemed as a **RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE** the above-named RELEASEES.

I understand that my attendance at a dog event is not without risk to myself, members of my family, guests who may attend, or my dog. I understand there are dangers involved in attending an event in which dogs are around strange people and other dogs, and that some accident or injury may result. I also understand that the location of this event may have wildlife present that could present a danger to my dog or result in parasite transmission to my dog. I understand that it is my sole responsibility to maintain control of my dog at all times while on the premises. I also understand that failure to control my dog at all times will be sufficient grounds for my dismissal from the event and forfeiture of all paid fees for said event.

I agree that the North American Sport Dog Association and Hat Trick Caos, LLC has the right to refuse this entry for any reason they deem sufficient within their sole discretion.
